2. Article IV is deleted in its entirety and the following substituted in lieu thereof:

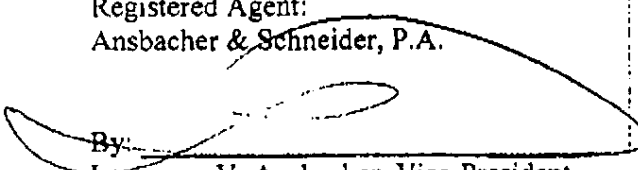
