The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make acknowledge and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be 66 Estates, LLC

ARTICLE II - ADDRESS

The mailing address and street address of the principle office of the company is:

ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective data as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - ADMISSION OF NEW MEMBERS

The remaining members of the company have the right to continue the business in the event of the termination of the company at any time due to death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member or the occurrence of any other event which terminates the continued membership of a member in the company, provided that all of the remaining members to do so in writing within 120 days after the date of a member's termination of membership.

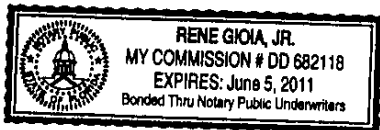

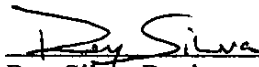
