ARTICLE I**NAME**

The name of the limited liability company shall be William & Eleanor Maloney Fund, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 3738 Creekside Drive, Sebring, Florida 33875.

The managers shall be elected in the manner set forth in the Operating Agreement of the Company. The managers shall hold the offices and have the responsibilities accorded to them by the members as set forth in the Operating Agreement.

DURATION

Corporate existence shall commence on the date these Articles of Organization are executed, except that if they are not filed by the Department of State of the State of Florida within five (5) business days thereafter, corporate existence shall commence upon filing by the Department of State.
