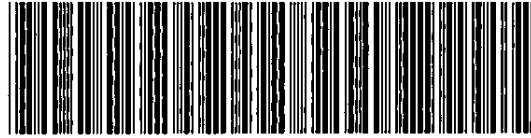

The undersigned being all of the Members and Managers of the Company have elected to dissolve the Company which is the purpose of these Articles of Dissolution.

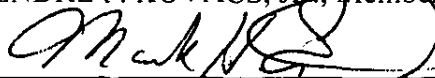
