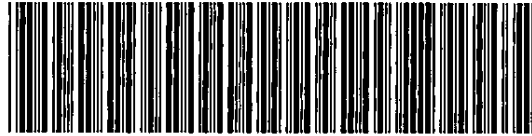

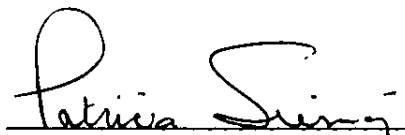
ARTICLE VII - DISTRIBUTION OF EARNINGS

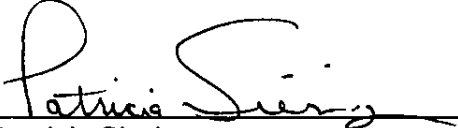

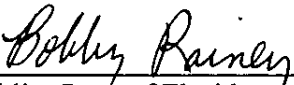

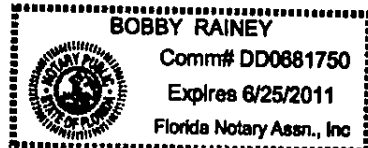
