The name and street address of the Company's initial registered agent is Ronald L. Stephenson, 2900 - 72nd Street North, St. Petersburg, Florida 33710.

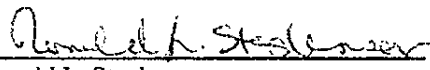
ARTICLE IV - PURPOSE

ARTICLE V - MANAGEMENT

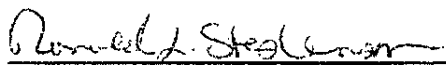
