The name of the Limited Liability Company is **USCX HOLDINGS LLC**.

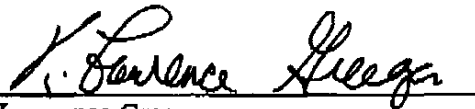
**ARTICLE II - ADDRESS**
