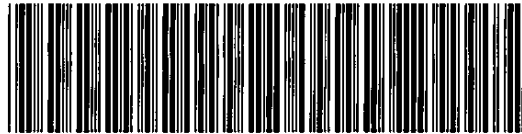



ARTICLES OF ORGANIZATION
of
PROJECT PAYDAY.COM, LLC
A Florida Limited Liability Company

ARTICLE 1
NAME

The name of this limited liability company is Project Payday.Com, LLC.


