## ARTICLES OF ORGANIZATION OF PUBILLONES MANAGEMENT, LLC

The undersigned member(s), or authorized representative of a member, for the purpose of forming a Limited Liability Company pursuant to Chapter 608, Florida Statutes, hereby adopts the following Articles of Organization.

#### **ARTICLE I - NAME**

The name of the Limited Liability Company shall be: Pubillones Management, LLC

#### **ARTICLE II - ADDRESS**

The principal place of business and mailing address of this Limited Liability Company shall be: 12503 SW 30 Street, Miami, Florida 33175.

#### ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

#### **ARTICLE IV - DURATION**

The Limited Liability Company shall exist in perpetuity.

#### **ARTICLE V - MANAGEMENT**

The Limited Liability Company is to be managed by its members, and the names and addresses of the initial members are:

#### <u>ARTICLE VI – ADMISSION OF ADDITIONAL MEMBERS</u>

The members of the Limited Liability Company shall have the right to admit additional members upon a majority vote of the existing members in accordance with Article XI, governing voting, contained herein.

#### ARTICLE VII – MEMBERSHIP AND MEMBERSHIP INTERESTS OF MEMBERS

In an event, no distribution may be made if, after the distribution, the Limited Liability Company would not be able to pay its debts as they came due in the usual course of business, or if the Limited Liability Company's total assets would be less than the sum of its total liabilities, excluding liabilities to members on account of their capital contributions.

#### <u>ARTICLE X – SHARING OF PROFITS AND LOSSES</u>

Sharing of profits and losses shall be allocated on the basis of each member's membership interest in the Limited Liability Company.

#### **ARTICLE XI – VOTING**

Members of the Limited Liability Company are entitled to vote on matters concerning the Limited Liability Company and each member's vote shall be weighted in accordance with each member's membership interest in the Limited Liability Company.

#### ARTICLE XII - WITHDRAWAL OF A MEMBER

A member of the Limited Liability Company may withdraw from the Limited Liability Company upon 45 days written notice to all other members provided that the withdrawing member has complied with all of the Articles of Organization and regulations of the Limited Liability Company and provided that all outstanding obligations of the withdrawing member to the Limited Liability Company have been satisfied.

#### ARTICLE XIII - MEMBERS RIGHTS TO CONTINUE BUSINESS

The remaining members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company provided that the remaining embers operate the business of the Limited Liability Company in full compliance with these Articles of Organization, the regulations of the Limited Liability Company and all applicable local, state, and federal laws.
