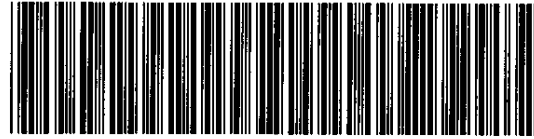




ARTICLE V


