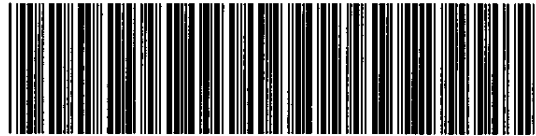



ARTICLE I
Name of Company

Clay Co. 214, LLC

ARTICLE II
Business of Organization

The limited liability company may engage in the business of owning, managing and leasing of real property, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III
Principal Place of Business

ARTICLE VI
Organization, Control and Structure of Company

Unless otherwise provided in the Operating Agreement, the filing for bankruptcy by a

The members remaining after the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or any other event which terminates the membership of a member, have the right to continue the business of this limited liability company subject to approval by the unanimous vote of the remaining members; provided that there is at least one remaining member.


