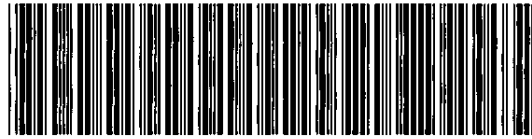

**ARTICLES OF ORGANIZATION**  
**OF**

**ARTICLE I - NAME**

The name of the limited liability company shall be CROMWELL INVESTMENTS, LLC (the "Company").

**ARTICLE II - MAILING ADDRESS AND STREET ADDRESS**
