**ARTICLES OF ORGANIZATION
FOR

The undersigned, acting as the organizer of MORGAN & MORGAN PROPERTIES, LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") is:

**ARTICLE II
INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS**
