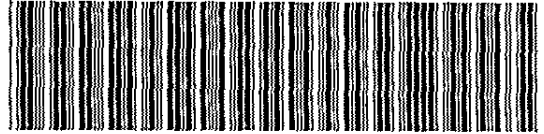

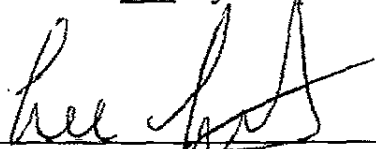
ARTICLE VI - Operating Agreement:

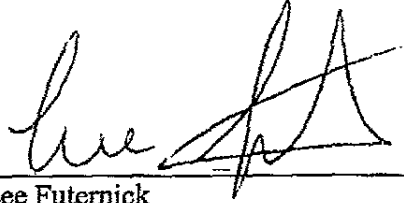
