

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF LOELLES, L.L.C.

Alcoholis and State of the Limited Co.

Pursuant to the provisions of the Florida Statutes, LOELLES, L.L.C., a Florida Limited: Liability Company, whose Articles of Organization were filed with the Florida Dept. of State of October 1, 2007, hereby adopts the following Amendment to its Articles of Organization of the Company.

- I. The following amendments to the Articles of Organization were adopted by the Company, the managers and the members of the Limited Liability Company, which shall be amended to read as follows:
- A. Article III of the filed Articles of Organization of the Company shall be deleted in its entirety and in its place and stead shall read:

"ARTICLE III

EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the managers and members of this limited liability company. This Article may be amended from time to time by the Operating Agreement of the limited liability company by a unanimous vote of the members of the limited liability company."

B. Article IV of the filed Articles of Organization of the Company shall be deleted in its entirety and in its place and stead shall read:

"ARTICLE IV

MANAGEMENT

This limited liability company is to be initially managed by the following managers:

C. Article V of the filed Articles of Organization of the Company shall be deleted in its entirety and in its place and stead shall read:

"ARTICLE V

MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all the members, as well as pursuant to any and all applicable provisions of the Company's Operating Agreement

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on majority consent of the remaining members."

- D. Article VI of the filed Articles of Organization of the Company shall be deleted in its entirety without replacement.
- II. This Articles of Amendment shall be effective at the time of its filing with the Florida Department of State.
