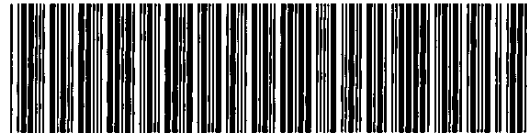



A-2 HOSPITALITY, LLC.


FIRST: The name of the limited liability company is A-2 Hospitality, LLC.
