# ARTICLES OF ORGANIZATION **OF** ATINA JÉBELLE, LLC

OTON TO SERVICE OF THE PARTY OF The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

### 1. Name.

The name of the limited liability company is ATINA JÉBELLE, LLC. (hereinafter referred to as the "Company").

### 2. Period of Duration.

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.
