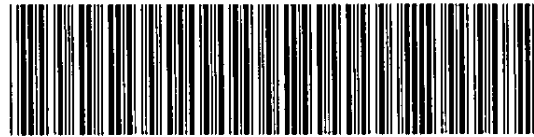

ARTICLE VI - LAWSUITS




