

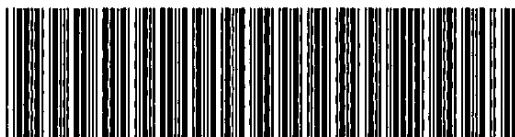

The Articles of Organization were filed on October 3, 2007, effective October 1, 2007.


**SECTION III - AMENDMENT TO THE ARTICLES OF ORGANIZATION**
