**ARTICLES OF ORGANIZATION
OF
PREMIER PERFORMANCE MARINE, LLC**

1. **Name.** The name of this limited liability company is Premier Performance Marine, LLC. (the Company).

2. **Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of 30 years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

3. **Purpose.** The Company is organized for the purpose of conducting marine service operations and transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. **Registered Agent and Office.** The name of the initial registered agent of the Company is A. Francisco Areces. The street address of the initial registered agent of the Company is 2121 SW Third Avenue, Suite 100, Miami, Florida 33129.

5. **Place of Business.** The Company's place of business is 2121 SW Third Avenue, Suite 100, Miami, Florida 33129.

6. **Additional Members.** Additional members to the Company may be admitted, but only upon the unanimous consent of all current members.

7. **Termination of Membership.** Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.

8. **Management of the Company.** The management of the Company is reserved to its members. The Company shall be managed in accordance with the regulations and operating agreement adopted by the members. The names and addresses of the members are:

9. **Regulations.** The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the management of the affairs of the Company.

10. Date of Existence of the Company. The existence of the Company shall commence on the date of filing the Articles of Organization by the Florida Department of State.

11. Transfer of Interest. No Member shall have the right to transfer any interest in the Company without the agreement of the other members in accordance with the Company's Operating Agreement. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

12. Certificated Interests. The members' interests in the Company shall be evidenced by certificates.
