ARTICLES OF ORGANIZATION OF BOCA RATON FAMILY AND PEDIATRIC CLINIC, P.L.

The undersigned, being a duly authorized person, desiring to form a professional limited liability company under and pursuant to Chapter 621, Florida Statues, does hereby adopt the following Articles of Organization:
