ARTICLES OF ORGANIZATION
OF
BOCA RATON FAMILY AND PEDIATRIC CLINIC, P.L.

The undersigned, being a duly authorized person, desiring to form a professional limited liability company under and pursuant to Chapter 621, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
DURATION

BOCA RATON FAMILY AND PEDIATRIC CLINIC, P.L., shall exist perpetually or until dissolved in a manner provided by law, or as provided in the Operating Agreement adopted by the members.

ARTICLE II
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the professional limited liability company shall be BOCA RATON FAMILY AND PEDIATRIC CLINIC, P.L., and its principal and mailing office shall be located at 19801 Hampton Drive, Units C 1-2, Boca Raton, Florida 33434, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of BOCA RATON FAMILY AND PEDIATRIC CLINIC, P.L. is 798 South Federal Highway, Suite 100, Boca Raton, Florida 33432, and the name of the company's initial registered agent at that address is LINDA O. MacLAREN.

ARTICLE IV
MANAGEMENT

The Company is to be managed by its members and is, therefore, a member-managed company.

ARTICLE V
PURPOSES AND POWERS

The general nature of the professional services to be rendered by this professional limited liability company shall be as follows:

- (a) To engage in every phase and aspect of the medical profession of rendering the same professional services to the Public that a

physician under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees, and agents, who are duly licensed under the laws of the State of Florida.

- (b) Without limiting the generality of any of the foregoing language, the professional limited liability company shall have all of the powers which are now or which may hereafter be conferred upon professional corporations by the laws of the State of Florida.
