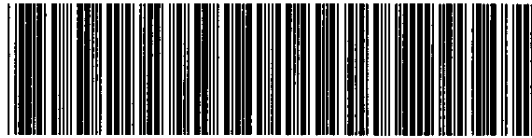

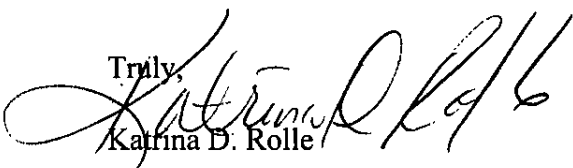

The name of the professional limited liability company is Veritas Medical Solutions, LLC

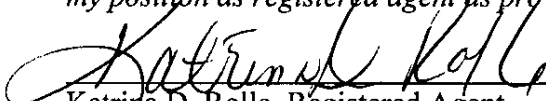
ARTICLE II – ADDRESS

ARTICLE IV – MANAGEMENT

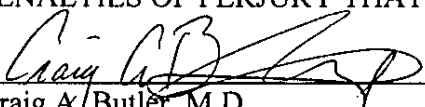
