**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

ARTICLE ONE - NAME

The name of the limited liability company shall be **POSSUM TROT, LLC** (the "Company").

ARTICLE TWO - COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date these Articles of Organization are accepted and filed with the Florida Department of State and shall continue until terminated in accordance with the Operating Agreement of the Company.

ARTICLE THREE - PRINCIPAL OFFICE AND MAILING ADDRESS

The initial mailing address and the street address of the principal office of the Company shall be: 840 Waterway Place, Longwood, Florida 32750.

ARTICLE FOUR - INITIAL REGISTERED OFFICE AND AGENT

The name and street address of the initial registered agent of the Company are: Beggs & Lane, a registered limited liability partnership, 501 Commendancia Street, Pensacola, Florida 32502. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment to these Articles of Organization.

ARTICLE FIVE - PURPOSES AND GENERAL POWERS

The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

ARTICLE SIX - MANAGEMENT

The Company is to be managed by one or more managers in accordance with the Company's Operating Agreement.

The Company shall adopt regulations for the Company, which regulations may contain provisions for the regulation and management of the business and affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608 of the Florida Statutes.


ARTICLE NINE - DURATION
