Address And Place Of Business**

The mailing and street address for the Company is 10 Bay Esplanade, Clearwater, Florida 33767.

**Article VI  
Registered Office And Registered Agent**

The street address of the Company's initial registered office in Florida is 1455 Court Street, Clearwater, Florida 33756, and the name of its initial registered agent is Linda Suzanne Griffin. The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 608.416, Florida Statutes.

**Article IX  
Admission Of Additional Members**

Except as otherwise provided in the Operating Agreement, no new members shall be admitted to the Company without the prior consent of a majority in interest of the existing members. Contributions required of a new member shall be determined by the members as of the time of the admission of the new member to the Company. A member's interest in the Company may not be sold or otherwise transferred except with the consent of a majority in interest of members or as otherwise provided for in the Company's Operating Agreement. Additional restrictions and conditions on membership may be set forth in Operating Agreement adopted by the members.

**Article X  
Operating Agreement**

The members of the Company may adopt an Operating Agreement pertaining to the regulation, management and affairs of the limited liability company, provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only by the members of the Company, in the manner now or hereafter prescribed in the Operating Agreement of the Company consistent with the laws of the State of Florida.

**Article XI  
Acknowledgment**

The members of the Company, through their undersigned authorized representative, do hereby certify that the foregoing constitutes the proposed Articles of Organization of SUNSET GREEN FLASH, LLC. These Articles of Organization may be amended from time to time by consent of the members holding a majority-in-interest of the Company, in the manner now or hereafter prescribed in the Company's Operating Agreement consistent with the laws of the State of Florida.


