**ARTICLES OF ORGANIZATION OF
GULF REGION RADIATION ONCOLOGY MSO, L.L.C.**

West Florida Medical Center Clinic, P.A., a legal entity competent to contract, presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I – NAME

The name of this limited liability company is:

GULF REGION RADIATION ONCOLOGY MSO, L.L.C.

ARTICLE II – PRINCIPAL OFFICE ADDRESS

The mailing address and street address of the principal office of this limited liability company is 8333 North Davis Highway, Pensacola, Florida 32514.

ARTICLE III – PURPOSES AND POWERS

This limited liability company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.

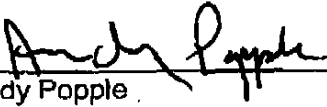
