**ARTICLES OF ORGANIZATION
OF
ATLANTIC RADIOLOGY CONSULTANTS, LLC**

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is **ATLANTIC RADIOLOGY CONSULTANTS, LLC**.

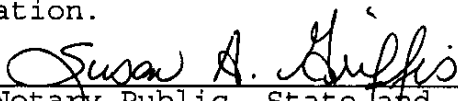

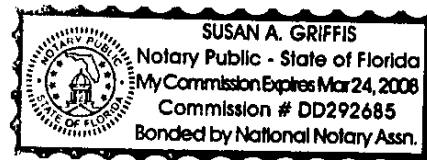
