ARTICLES OF ORGANIZATION

OF

JRS CUSTOM HOMES, LLC

The undersigned initial members of J R S CUSTOM HOMES, LLC, a Florida limited liability company formed hereunder (the "Company"), hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I. COMPANY NAME
