ARTICLES OF ORGANIZATION OF H & B FINANCIAL, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be H & B FINANCIAL, LLC ("company").

ARTICLE II -- ADDRESS

The mailing address of the company is 125 CR 400 Lake Panasoffkee, Fl 33538 and street address of the principal of the company is the same.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV -- REGISTERED OFFICE AND AGENT
