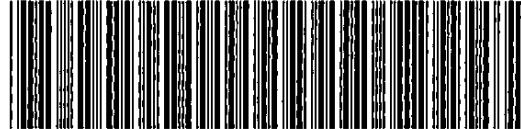

**ARTICLE IX – MEMBERS LIMITED LIABILITY**

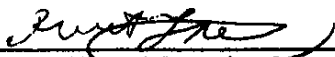
The liability of the members shall be limited as provided under the laws of the Florida Limited Liability statutes.
