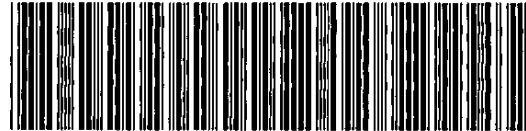

Admission of Additional Members


Member(s) shall have the right to admit additional members as provided in the Company's operating agreement.


