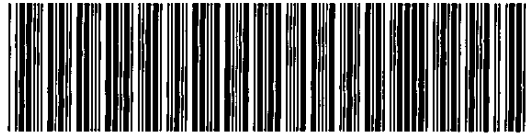

TO THE SECRETARY OF THE STATE OF FLORIDA:

Per Florida Statutes Chapter 608, the undersigned adopts the following articles of organization for the company.

ARTICLE I  
NAME

The name of the limited liability company is Divide and Conquer, LLC.

ARTICLE II  
REGISTERED OFFICE AND AGENT

The mailing and street address of the principal office of Divide and Conquer, LLC is 2346 Foggy Ridge Parkway, Land O' Lakes, FL 34639.

ARTICLE III  
REGISTERED AGENT AND PRINCIPAL OFFICE

The name of the initial registered agent for Divide and Conquer, LLC is Chantel M. Mijo.

ARTICLE IV  
MANAGING MEMBERS

Divide and Conquer, LLC shall be managed by managing members. The name and address of the sole current managing member is

Other managing members may be added from time to time. The managing members shall have all the duties, powers and authority as set out in the Operating Agreement for Divide and Conquer, LLC.


ARTICLE V  
INDEFINITE PERIOD OF DURATION

Divide and Conquer, LLC's existence shall commence on the date of the filing of the Articles of Incorporation with the State of Florida, and, thereafter, Divide and Conquer, LLC's existence shall be perpetual without term. It shall be dissolved only per Florida Statutes 608.441, or by a unanimous decision by its company members.

ARTICLE VI  
NONLIABILITY AND INDEMNIFICATION

- A. No member of Divide and Conquer, LLC shall be personally responsible or liable for any of the debts, liabilities, or losses of the company.
- B. Each person who is or was a member of Divide and Conquer, LLC (and any heirs, executors, personal representatives, or successors thereof) who was or is made a party to, or is involved in any threatened, pending or completed legal action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that such person is or was a ("Indemnitee") shall be indemnified and held harmless by Divide and Conquer, LLC to the fullest extent provided by applicable law. In addition to the indemnification provided in this Article, the Indemnitee shall also be entitled to have paid directly by Divide and Conquer, LLC the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law current to the time of such events. The right to indemnification conferred in this Article shall be contract tight.
- C. Divide and Conquer, LLC may, by action of the members, provide indemnification to member, employee or agent of said company to such extent and to such effect as the members shall determine to be appropriate and authorized by applicable law.
- D. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or subsequently acquire under any statute, provision of the Articles of Organization or Operating Agreement of Divide and Conquer, LLC, agreement, vote of members, or otherwise.
- E. Any repeal or amendment of this Article by the members of Divide and Conquer, LLC shall not adversely affect any right or protection of any member or employee existing at the time of such repeal or amendment.
