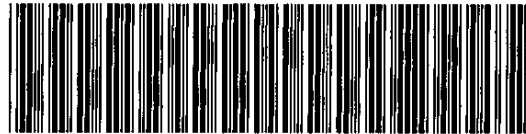

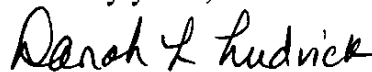

**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the Limited Liability Company shall be **LUDVEL, LLC**, (hereinafter referred to as the "**Company**").

**ARTICLE II - ADDRESS**

The initial principal place of business of Company in Florida shall be 2400 Weatherford Drive, Deltona, FL 32738 and the mailing address shall be the same.

**ARTICLE III - EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

**ARTICLE IV - SPECIFICATION OF PURPOSE**

The purpose for which Company is organized is to transact any and all lawful business for which limited liability companies may be organized under the laws of Florida, including, but not limited to, the following:

- (a) To carry on any business or any other legal or lawful activity allowed by law;
- (b) To acquire, own, use, convey, and otherwise dispose of any deal in real or personal property or any interest in such property;

- (c) To manufacture, buy, sell and generally deal in good, wares and merchandise of every class and description;
- (d) To buy, rent, sell, manufacture, produce, assemble, distribute, repair, and service any and all products or services in which the company desires to engage;
- (e) To do such other acts as are incidental to the foregoing or desirable in order to accomplish the purpose for which the company was formed;
- (f) To have and exercise all rights and powers that are now or may hereafter be granted to a limited liability company by law.

The foregoing shall be construed as objects, purposes and powers and enumeration thereof and shall not be held to limit or restrict in any manner the powers hereafter conferred on Company by the laws of the State of Florida.

#### **ARTICLE V - DURATION**

The period of duration for Company shall begin with the filing of these Articles with the Florida Department of State, and shall continue perpetually until dissolved.

#### **ARTICLE VI - MANAGEMENT**

The management of Company is reserved to the members. The members of Company are:

## **ARTICLE VII – EXERCISE OF POWERS**

All Company powers shall be exercised by or under the authority of, and the business and affairs of Company shall be managed under the direction of, the members of Company. This Article may be amended from time to time in the regulations of the Company by a unanimous vote of the members of Company.

## **ARTICLE VIII – PROFITS AND LOSSES**

- (a) The members shall be entitled to the net profits arising from the operation of Company's business that remain after the payment of the expenses of conducting the business of Company
- (b) All losses that occur in the operation of Company's business shall be paid out of the capital of Company and the profits of the business.

## **ARTICLE IX – MEMBERSHIP RESTRICTIONS**

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time admission to the Company.

A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members.

## **ARTICLE X – RIGHT TO CONTINUE BUSINESS**

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in Company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

**ARTICLE XI - REGISTERED AGENT AND REGISTERED OFFICE**
