ARTICLES OF ORGANIZATION OF Education Unlimited Academies, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act.

- 1. Name: The name of the limited liability company is Education Unlimited Academies, LLC.
- Duration: The Company shall exist from the date of the filing of these Articles with the Secretary of State until the occurrence of any of the events specified in Florida Statutes, unless continued by the unanimous consent of all of the remaining members.
