The name of the limited liability company is Peregrine Golf Ventures, LLC.

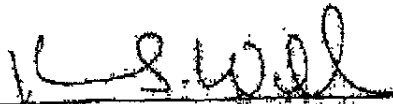

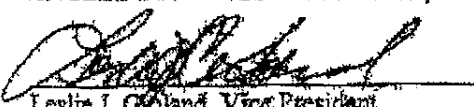
