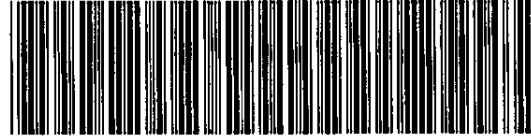

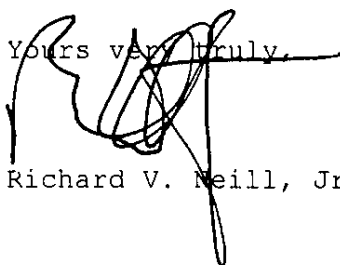

ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
ST. LUCIE KIDNEY CARE, LLC

Pursuant to Section 605.0202, *Florida Statutes*, the undersigned limited liability company submits these Articles of Amendment to its Articles of Incorporation and states:

1. The name of the company is ST. LUCIE KIDNEY CARE, LLC.
2. The Articles of Organization were filed on October 19, 2007, and assigned Florida document number L07000106734.
3. The Articles of Organization are amended by replacing Article VII in its entirety, as follows:

Article VII

4. The company's Articles of Organization are amended by addition of Article VIII, as follows:

Article VIII

The member(s) may in accordance with the regulations referenced in Article VII change or add managers, each of which shall have full authority to act for the company on any matter. The members may also change the registered agent by vote or written action of a majority of in interest, effective upon filing the required documents.

5. The date of adoption of these Articles of Amendment is the 3rd day of May, 2018, and these amendments shall be effective upon filing.
