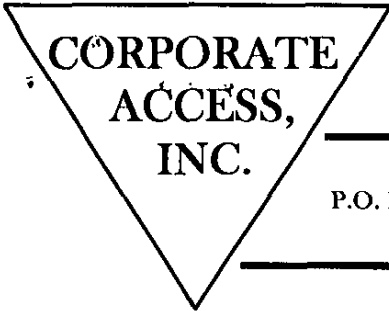

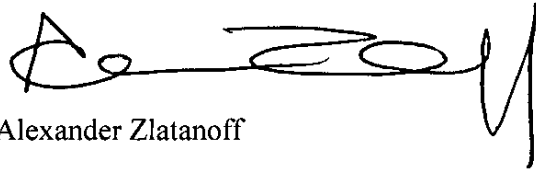

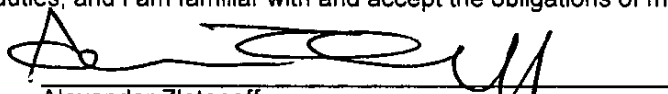
ARTICLE III

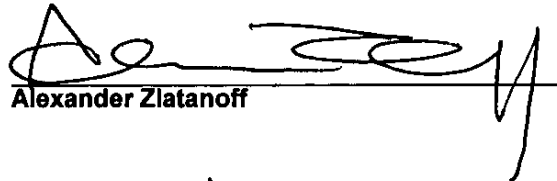
ADMISSION OF ADDITIONAL MEMBERS

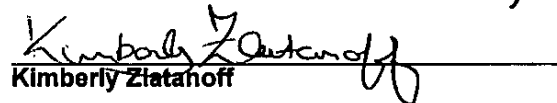
The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be the unanimous consent of all the Members.
