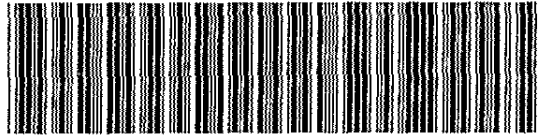

The name of the Limited Liability Company is: GLO LITES, L.L.C.

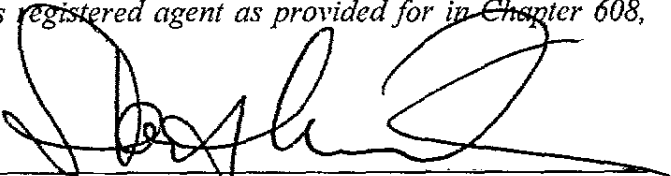
ARTICLE II - ADDRESS

The enumeration of objects or purposes herein shall not be deemed to exclude or in any way limit by inference, any powers, objects or purposes which this corporation is empowered to exercise, whether expressly by force of the laws of the State of Florida, now or hereafter in effect or implied by any reasonable construction of said law.

ARTICLE VII

This Limited Liability Company shall have a perpetual existence from the date of organization unless dissolved according to law.
