### A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is VLW, The (the "Company"), and it shall be formed as a Florida limited liability company und that the formed Statutes.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of the Article's of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
- 4. <u>Place of Business</u>. The mailing address and street address of the Company's principal office is 12626 Tamiami Trail South, Fort Myers, Florida 33907.

- 9. <u>Voting</u>. The Company is authorized to issue membership units with voting rights and membership units without voting rights.
- 10. <u>Certificated Interests</u>. The members' interests in the Company may be evidenced by certificates.
