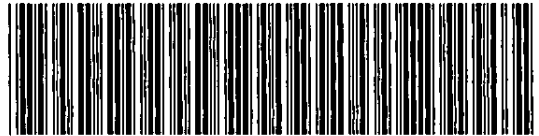

ARTICLE IV - MANAGEMENT

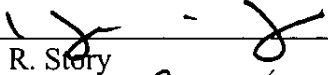

ARTICLE V - EFFECTIVE DATE

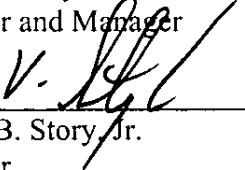
The effective date of these Articles of Organization, and the beginning of the existence of the company, shall be the date of filing of these Articles of Organization.

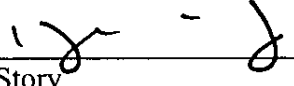
