The undersigned, desiring to form a limited liability company under and by virtue of the laws of the State of Florida and specifically pursuant to the provisions of Chapter 608, *Florida Statutes* (2007), does hereby execute these *Articles of Organization*.

## ARTICLE I NAME AND PRINCIPAL OFFICE
