

ARTICLES OF ORGANIZATION

MAIA MEDIA, LLC A Florida Limited Liability Company

ARTICLE I NAME

The name of this limited liability company is MAIA MEDIA, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE IX APPLICABLE LAW

The Limited Liability Company is created pursuant to Chapter 608, Florida Statutes, and shall be governed by the laws of the State of Florida.
