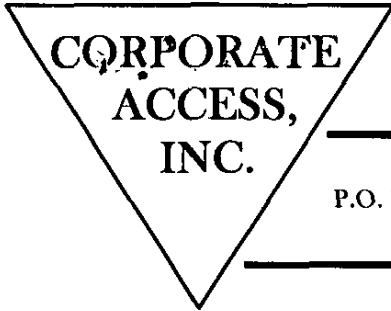

ARTICLE III - MANAGEMENT


