REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Stephen A. Allen, 2531 NW 35th Street, Ocala, Florida 34475.

ARTICLE VI

CAPITAL CONTRIBUTIONS


