**ARTICLES OF INCORPORATION
OF

Pursuant to Sections 608.407 and 621.051 of the Florida Statutes, the undersigned hereby files these Articles of Incorporation as follows:

**ARTICLE I
NAME**

The name of this professional limited liability corporation is:

(hereinafter referred to as the "Company")

**ARTICLE II
ADDRESS**

MANAGEMENT**




**ARTICLE V
PURPOSE**

Pursuant to the authority granted under Chapter 621, Florida Statutes, the Company is formed for the purpose of providing professional legal services through attorneys at law, who may be members, officers, employees or agents, duly licensed or otherwise authorized to render such professional legal services within the State of Florida. The purpose and character of the business of the Company shall be to engage in every aspect of the profession of law and to engage in any and all activities permitted by law in furtherance of the business of the Company. The foregoing shall not be deemed to limit or restrict in any manner the general powers of the Company and the exercise thereof as conferred by the laws of the State of Florida upon professional limited liability companies to provide professional legal services under the provisions of Chapter 621, Florida Statutes (as it now exists or is hereinafter amended), including, without limitation, the power to invest funds of the Company in real estate, mortgages, stocks, bonds or any other type of investment, and the power to own real and personal property necessary for the rendering of its professional legal services.
