

ARTICLES OF INCORPORATION

OF

ALEXANDER ANGUEIRA, P.L.L.C.

Pursuant to Sections 608.407 and 621.051 of the Florida Statutes, the undersigned hereby files these Articles of Incorporation as follows:

ARTICLE I

The name of this professional limited liability corporation is:

Alexander Angueira, P.L.L.C. (hereinafter referred to as the "Company")

ARTICLE II ADDRESS

The Company's principal place of business shall be at Plaza 57, 7301

S.W. 57th Court, Suite 515, South Miami, Florida 33143 and such other place or places as the members from time to time may determine. The mailing address is the same as the principal place of business.

ARTICLE III INITIAL REGISTERED AGENT

The name and street address of the Company's initial registered agent shall be Alexander Angueira, Plaza 57, 7301 S.W. 57th Court, Suite 515, South Miami, Florida 33143.

ARTICLE IV MANAGEMENT

The Company is to be managed by one or more managers, and therefore is a manager-managed company. The name and address of the initial manager of the Company shall be Alexander Angueira, Plaza 57, 7301 S.W. 57th Court, Suite 515, South Miami, Florida 33143. Unless expressly provided otherwise in the Company's operating agreement, the Company shall indemnify and hold harmless any manager or member, and any former manager or member, to the fullest extent permitted by law.

ARTICLE V PURPOSE

Pursuant to the authority granted under Chapter 621, Florida Statutes, the Company is formed for the purpose of providing professional legal services through attorneys at law, who may be members, officers, employees or agents, duly licensed or otherwise authorized to render such professional legal services within the State of Florida. The purpose and character of the business of th Company shall be to engage in every aspect of the profession of law and to engage in any and all activities permitted by law in furtherance of the business of the Company. The foregoing shall not be deemed to limit or restrict in any manner the general powers of the Company and the exercise thereof as conferred by the laws of the State of Florida upon professional limited liability companies to provide professional legal services under the provisions of Chapter 621, Florida Statutes (as it now exists or is hereinafter amended), including, without limitation, the power to invest funds of the Company in real estate, mortgages, stocks, bonds or any other type of investment, and the power to own real and personal property necessary for the rendering of its professional legal services.
