

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

#### **ARTICLE I – NAME**

The name of the limited liability company shall be ROBERT KING DEMOLITION & HAULING, LLC (the "Company").

#### ARTICLE II - ADDRESS

The Company shall be managed by two or more member(s) in accordance with regulations adopted by the members for the management of the business and affairs of the Company and is therefore a member managed company. The regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with Florida law or these Articles of Organization.
