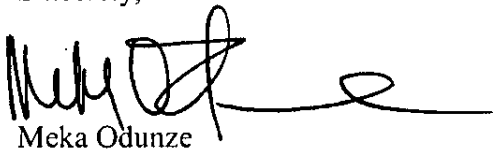

"To engage in the transaction of any or all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act."

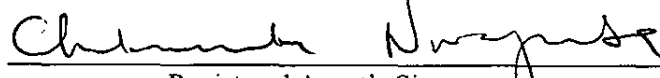

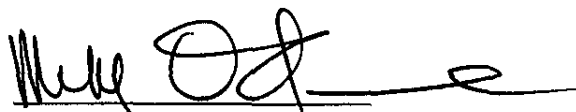
