

#### ARTICLES OF ORGANIZATION

Pursuant to section 608.407 of the Florida Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

#### ARTICLE 1 NAME

The name of the limited liability company (the "Company") is PVBD, LLC.

#### ARTICLE II DURATION

Unless earlier terminated pursuant to the Act or the Operating Agreement (as defined § 608.402 (24) of the Act) of the Company, the period of its duration shall be perpetual.
