1. The Name of the limited liability company is: RFHS Ventures, LLC ("Company").


2. The date of filing of the Articles of Organization of the Company was October 30, 2007 and assigned document number L07000109916.

3. The Company amends its Articles of Organization by changing its name to RFHWS Ventures, LLC. Article I of the Articles of Organization is amended to change the name of the Company to RFHWS Ventures, LLC.

4. Except as amended hereby, the Articles of Organization shall remain in full force and effect.
